# **Executive summary**

Survivors of childhood sexual violence are not just victims they are experts. Yet their voices remain systematically excluded from policymaking. National Survivor Councils (NSCs) institutionalize survivor leadership, ensuring policies are co-designed by those with lived experience, transforming theory into real-world impact.

Why survivor leadership matters:

- 1 in 5 children globally experience sexual violence (WHO, 2024).
- Policies fail when survivors aren't at the table, perpetuating gaps in prevention, justice, and support.
- Germany, France, and the UK (via G7 commitments) have pioneered NSCs now the G20 must scale this model worldwide.

#### Brave Movement's demands for G20 leaders:

- Commit to establishing National Survivor Councils in all G20 countries by 2027?
- Endorse the Council of Europe's Survivor Engagement Guidelines for ethical, transparent inclusion.
- Fund and institutionalize survivor-led policymaking at all government levels.

#### 1. The case for national survivor councils

The Problem: policies without survivors fail

Most child protection laws are designed without survivor input, resulting in:





- Weak prevention strategies that miss real risks (e.g., digital exploitation).
- Inaccessible justice systems that retraumatize victims.
- Tokenism (one-off consultations ≠ sustained leadership).

The solution: Institutionalizing survivor leadership

#### NSCs ensure:

- Trauma-informed, practical policies.
- Accountability to those affected.
- Prevention strategies grounded in lived experience.

#### Global success stories:

- Germany: Independent Federal Commissioner Against Child Sexual Abuse (survivor-led since 2022).
- France: National victims council project pledged by the former Prime Minister François Bayrou. Process underway to implement this pledge.
- UK: G7 commitment (2025 pledge to launch an NSC).

#### 2. How G20 countries can establish NSCs

### Step 1: Legal mandate and funding

- Legislate NSCs via child protection reforms.
- Dedicate national budget lines for NSC operations.
- Sensitisation, community dialogue, and localisation of solutions.

#### Step 2: Ethical recruitment and support

- Recruiting with the diversity of survivor / lived experiences in mind to prevent a monolith
- Compensate survivors for expertise (no unpaid labor).
- Provide trauma-informed training for members and officials.

#### Step 3: Decision-making power

- NSCs must co-draft laws—not just review them.
- Mandate NSC seats in government task forces (e.g., Al/digital safety).

### Step 4: Transparency and accountability

Publicly report on NSC impact (annual progress to parliament).





Adopt the Council of Europe's Guidelines to prevent tokenism.

#### 3. G20 action plan

Immediate steps for leaders

- Announce NSC commitments at the 2025 G20 Summit.
- Launch a G20 Survivor Councils Working Group to share best practices.
- Pool funding via World Bank/IMF to support lower-income countries.

# Long-term success metrics

By 2026: All G20 nations draft NSC laws.
By 2027: 50% of child protection policies co-written by survivors.
